**Subcommittee Reports**

Works of Art-Julia Bergman

*Uptight* by Jacques Overhoff will be freed from construction material and moved about ten feet back. An Art Dept. student proposal to re-paint the work was approved by the W/A Committee.

*Song of the Spirit*, the Student Union mural, has been further disfigured by ADA signs directing students to the elevator. Precita Eyes Director Susan Cervantes is preparing a cost estimate for the restoration of the mural.

It is hoped that the Sargent Johnson bas relief molds can be stored in the space being vacated by Hunt Construction.

Pacifica, the 8' fiberglass replica of the original statue on Treasure Island, will be dedicated on Thursday, April 17. This is a gift from former Aquacade swimmer Sal DeGuarda.

The IPP for the Center for Pan American Unity is being developed by a coalition of media and arts departments, who collaborating to share space, resources and students.

We are waiting for a cost estimate for the restoration and installation of Robert Howard's Whale Fountain.

We will assist lawyer Ginny Riegel with new language for the District Policy Manual, Section 7.18.

**Facilities Updates**

C/NB Design Review-Joanne Low

Based on many comments and suggestions from staff and the community, the design has evolved into a beautiful and functional campus. The FRC recommended the schematic

design on February 27, 2008. The Board of Trustees will receive the design on Thursday, April 24.

#### Path of Travel

The project was completed by the March 31, 2008 deadline. The firm hired for the work, Proven, was excellent; they worked under difficult conditions with classes in session, and in poor weather. 2010 is the next deadline for ADA upgrades to restrooms, drinking fountains, 30% of general purpose classrooms and all specific labs throughout the College District.

#### Joint Use Building

The College still does not have title to the east side of the Balboa Reservoir; discussions with the PUC continue.

#### Gymnasium De-construction

Bids are out and some responses have come in. The project will cost \$1.5-\$2million; the vacant site will be converted into parking lots to recover spaces lost by the construction of the Joint Use Building on the reservoir.

#### Bonds

The General Hospital \$887 million bond will go before the voters in November and will require a 2/3 vote.
