International Student Financial Support Form

NOTE: *This form **and** official documentation must be submitted together & are mandatory for issuing an I-20. Certified copies of original bank statements or letters will be accepted if we can verify their authenticity. This form **must** be notarized on the second page if the student is being sponsored by a legal permanent resident, U.S. citizen or government entity. Failure to notarize this form as outlined above will delay the application process.*

All international students who need to obtain a new I-20 must show proof of sufficient funds to cover a full year of expenses at City College of San Francisco. The documentation may consist of either **bank account balance statements or letters written by financial institutions with explicit numerical balances** and must be dated within six (6) months. **The financial documentation must show a minimum balance of the amount listed below.** The funds must be “liquid” (such as a checking or savings account), such that monies could be withdrawn at any time. Business accounts, insurance policies, certificates of deposit, retirement accounts, and investments **are not** sufficient. If the currency is not in U.S. dollars (USD), the currency must be listed. If the documentation is not in English, we require an **official** translation into English. All documentation **must be certified** - signed or stamped by a bank official – if the account resides outside the United States. Sponsorship within the United States does not require a certified bank document; however, the bank statement must be official, and the name of the account holder must match the name listed on the second page of this form.
