Textbook Adoption Resolution Draft 9-23

Whereas, Faculty have both the academic freedom to select the course materials they deem most appropriate and the responsibility to consider the cost burden as they do so;

Whereas, Provisions of the Higher Education Opportunity Act requires each institution of higher education receiving federal financial assistance to "disclose, on the institution's Internet course schedule and in a manner of the institution's choosing, the International Standard Book Number and retail price information of required and recommended college textbooks and supplemental materials for each course listed in the institution's course schedule used for pre-registration and registration purposes"; and

Whereas, California Education Code §66406.9 requires the California Community Colleges to "clearly highlight, by means that may include a symbol or logo in a conspicuous place on the online campus course schedule, the courses that exclusively use digital course materials that are free of charge to students and may have a low-cost option for print versions"; and

Whereas, the OER committee worked with the bookstore and cross-constituent groups to design a revised process for collecting faculty textbook adoptions and providing consistent and clear messaging to students prior to registration regarding all material and supply costs in appropriate locations including the schedule of classes and the bookstore; therefore be it

Resolved, that the Academic Senate for City College of San Francisco endorses the revised book adoption process, as presented on October 18, 2023.

Draft Resolution - Endorsement of ILO2 Learning Outcomes Report

Whereas Institutional Learning Outcomes (ILOs), rooted in the Mission of the College, define and identify the knowledge, behaviors, and skills the College would like students to acquire and develop throughout their CCSF educational experiences;

Whereas the Institutional Assessment Plan specifies that Institutional Learning Outcomes (ILOs) shall be assessed on a regular basis through a process with broad faculty participation coordinated by the Student Learning Outcome (SLO) Coordinators and the Academic Senate's Student Learning Outcome Committee (SLOC);

Whereas a thorough assessment of ILO 2, Communication, was conducted in 2022-2023 and included multiple measures and dialogue about the ILO, including quantitative analysis of assessments of SLOs mapped up from courses through programs to ILOs; five case studies to capture student experiences with ILO 2; and in-depth discussion at the SLOC meetings on several occasions;

Whereas the results of this assessment were compiled into the Spring 2023 ILO 2 Assessment Report by the SLO Coordinators and approved by the SLOC on September 1, 2023, and are available to share with the college community and the community at large;

Be it resolved that the Executive Council of the Academic Senate receives and accepts the Spring 2023 ILO 2 Assessment Report; and be it further

Resolved that the CCSF Academic Senate Executive Council recommend that this report be used, when relevant, during planning and improvement processes.
