

  - Student Equity Plan 2022–2025 (submitted 11/2022)
  - RiSE / Scale of adoption assessment SOAA (3/2022)
  - Quality Focus Essay (QFE) for the Institutional Self Evaluation Report (12/2022)
- Integration with other state programs and initiatives
  - Student Equity and Achievement Program (SEA), Adult Education Program (AEP), Strong Workforce Program (SWP); Zero Textbook Cost initiative (ZTC), Associate Degree for Transfer initiative (AD-T)



# CONNECTION TO CCSF'S EDUCATION MASTER PLAN

- Our Education Master Plan (EMP) drives all planning efforts at the college
- The GP work plan will help CCSF to carry out EMP goals
  - Improve the Student Experience
  - Institutionalize Equity
  - As well as
    - strengthening credit and noncredit programs;
    - improving communications;
    - improving the operation of the college; and
    - increasing opportunities for professional development

- RiSE work as reflected in the Scale Of Adoption Assessment (SOAA) 2022
  - Accomplishments
  - Areas, strategies and activities remaining to be addressed
- Quality Focus Essay planning (QFE) 2022
  - Logic model focused on Student majors & educational goals, and Student resources and services
- SEA, AEP, SWP; ZTC. AD-T leads reflections on integration-related accomplishments, strategies and activities

# DRAFT FRAMEWORK: PILLARS & SUCCESS FACTORS

#### • Pillars

- 1. MAPPING Pathways to student end goals
- 2. HELPING STUDENTS Choose and ENTER A program PATHWAY
- 3. KEEPING STUDENTS ON PATH
- 4. ENSURING THAT STUDENTS ARE LEARNING
- Success Factors
  - Directed: students have a goal and know how to achieve it [pillars 1, 2]
  - Focused: students stay on track keeping their eyes on the prize [pillar 3]
  - Nurtured: students feel somebody wants and helps them to succeed [pillar 3]
  - Engaged: students actively participate in class and extracurricular activities [pillar 4]
  - Connected: students feel like they are part of the college community [pillar 3]
  - Valued: students' skills, talents, abilities and experiences are recognized; they have opportunities to contribute on campus and feel their contributions are appreciated [pillar 4]
