Hi Adil,

There is a special provision in statute for Compton and San Francisco that extends adding COLA to the hold harmless amount for one more year than the rest of the system:

Education Code 84750.4 (g)(3)(A) establishes that the rates used for the SB 361 Hold Harmless Provision calculation for San Francisco Community College District shall be adjusted by COLA through fiscal year 2025-26 and the number of FTES be adjusted for any increases. The intent of these adjustments is to provide San Francisco CCD with the greater of the amount that would have been calculated under SB 361 in fiscal year 2017-18 adjusted for COLA and any increases in FTES, or the amount calculated by the SCFF. The SB 361 Hold Harmless Provision calculation has not exceeded the SCFF or other TCR level funding protections for San Francisco CCD to date, although with the end of the COVID-19 emergency conditions allowances this could change.
