- A. The possession, sale, consumption or furnishing of alcoholic beverages is prohibited on District property except in connection with a course of instruction, at a district special event, or at an event to benefit a nonprofit corporation.
  - 1. Alcoholic beverages may be acquired, possessed, used, sold or consumed in connection with a course of instruction, sponsored dinner, or meal demonstration given as part of a culinary arts program.
  - 2. "Special event" means festivals, shows, parties, concerts, theatrical productions, and other events held on the premises for which the principal attendees are members of the general public and not employees or students of the college. .
  - 3. Events sponsored by the District or the Foundation for City College of San Francisco may be approved by the Chancellor. Application for such an event shall be made to the Vice-Chancellor, Finance and Administration at least ten days in advance of the event.
  - 4. Other non-profit public benefit corporations may hold events including alcoholic beverages with the permission of the Board of Trustees. Application for such events shall be made to the Vice-Chancellor, Finance and Administration at least 45 days in advance of the event.
  - 5. Alcohol may not be possessed, served, or consumed on District property at an event at which the principal attendees are employees and/or students.
  
- B. No alcoholic beverages are permitted under any circumstances at college football games or other athletic contests.
  
- C. The possession, sale, consumption or furnishing of alcoholic beverages shall be approved by the California Department of Alcohol and Beverage Control (ABC) through its permit process. The person obtaining the permit shall be responsible for compliance with ABC regulations. The person obtaining the permit may request assistance of the district police department with respect to the enforcement of alcohol laws and ABC regulations.
  
- D. Violators are subject to disciplinary action, criminal prosecution, fine and imprisonment.
  
- E. It is unlawful to sell, furnish or provide alcohol to a person under the age of 21. The serving or possession of alcohol by anyone under 21 years of age in a public place or a place open to the public is illegal.

- F. It is a violation of this procedure for anyone to consume or possess alcoholic beverages in any public or private area of the college except in connection with a course of instruction or an event authorized in accordance with these procedures..
  
- G. All courses authorized to use alcoholic beverages include a notification to the students by the instructor that all students must be 21 years of age or older to serve, consume or possess alcoholic beverages, which requirement shall be enforced by the instructor.
