



EMERGENCY MEDICAL TECHNICIAN (EMT)

This program prepares students to meet National EMS Education Standards and State of California requirements for EMT course completion and to take the National Registry of Emergency Medical Technicians (NREMT) basic level EMT Examination. EMT course completion and NREMT certification is a prerequisite to Paramedic Program enrollment. Course completion and NREMT certification may lead to EMT certification from the California Emergency Medical Service Authority (EMSA), providing the student does not have a drug or criminal history that would preclude certification. Concerns regarding applicants' particular background record should be addressed with the San Francisco EMS Agency at (415) 487-5000.

PROGRAM REQUIREMENTS:

1. Must be 18 years of age and fulfill all requirements for enrollment in credit courses at CCSF.
2. PREREQ: Current AHA Basic Life Support Provider CPR card. Certification must be for American Heart Association course only (no other CPR cards will be accepted). CCSF offers EMT 12 BLS Provider course.
3. Attend one mandatory EMT Program orientation meeting (approx. one hour)

CERTIFICATION REQUIREMENTS: Following successful completion of EMT 100 class, California EMT Certification requires the following:

1. Passing score on National Registry Certification Exam – test fee.
2. Proof of Live Scan fingerprinting or Criminal background search – agency fee
3. Application to EMS Agency – agency fee

5 STEPS COLLEGE ADMISSION PROCEDURES

1. Apply for Admission: Go to [Admissions & Registration](#) or call 415-239-3285.
 - **NEW CREDIT STUDENTS:** Fill out a CCSF **credit** application at [Credit Admission](#) or call 415-239-3285
 - **RETURNING STUDENTS:** Have attended CCSF before as a **credit** student, but have not enrolled in courses for 2 consecutive semesters (Spring & Fall) or more, reapply (update your personal information) at [Credit Admissions](#). Go to step 3. If you have only been away for one semester, you are considered a [Continuing Student](#).
2. Attend an orientation for the health program of interest. After orientation if there are no questions about registration, tuition & fees, financial aid, or other student services go to step 5.
