 - E. 3 Administrators, Chief of Police and Director of Buildings and Grounds are recommended (Appointed by Chancellor, after consultation with Administrative Council)

Term limits subject to appointing body. Any member may be called upon during an Occupational Safety and Health Administration (OSHA) investigation, so committee members are strongly encouraged to complete a ten hour OSHA safety course to improve understanding applicable to this committee. [1]

- IV. COMMITTEE CO-CHAIRS: Risk Manager and Director of Student Health
 - A. Co-Chairs report in written (monthly) and oral (twice/year) format to Participatory Governance Council.
 - B. Co-Chairs set meeting agendas and post committee minutes.
- V. **GOAL:** This Committee meets as required to assist the College in promoting a healthy workplace and educational environment free of recognized physical and environmental hazards.

VI. PURPOSE AND RESPONSIBILITIES:

- A. A proactive approach to health and safety protects District investments in the lives of employees and students, employee productivity, and District reputation
- B. Understand, discuss, and evaluate trend data on employee and student injuries and illnesses on District property to make recommendations on prevention of similar events
- C. Understand, discuss, evaluate, and make recommendations about the District Emergency Procedures Manual
- D. Understand, discuss, evaluate, and make recommendations about the Injury and Illness Prevention Program (IIPP - 8CCR3203), including safety communications, facility safety inspections, and employee safety and compliance training [2]
- E. Discuss and evaluate outstanding work orders related to health and safety
- F. Review and make recommendations regarding the District's resource allocation related to health and safety
- G. Fulfill committee obligations as set forth in the annual board and college goals.
- H. Fulfill committee obligations to college accreditation.
- I. Convene meetings no less than quarterly.
