Student Success & Equity

- ❖ Establish new and enhance existing programs and initiatives that meet the needs and interests of all students, which improve access, retention, engagement, persistence, and completion
- Establish new and enhance existing services that support personal health, wellness, and safety
- ❖Improve communication and transparency in the planning and decision-making process
- ❖Foster a culture that promotes anti-racism, equity-mindedness, inclusivity and belonging



Campus Partnerships

- Use technology to consistently connect with students to increase enrollment, retention and completion
- Assure clarity in student pathways, help every student explore career/college options, choose a program of study, and develop a full-program plan as soon as possible in order to provide a more seamless and supported student experience
- Strengthen collaboration between counseling and other support services and academic programs to support students in academic and career communities.



Student Affairs Structure, Stability and Service Delivery Model

- ➤ Having a clear organizational structure/chart with clear roles and responsibilities connected to Student Affairs mission statement
- Improve integration between programs (credit/non-credit), departments, locations through cross training, professional development, shadowing, and collaborative meetings



Community Partnerships

- Strengthen access to certificate and degree programs for high school students
- Expand access to educational opportunities for Noncredit adult education students
- Expand opportunities for the local workforce to strengthen skills, advance, and/or change careers
- Engage Community Partnerships to support the needs of current CCSF students (e.g., academic, socio-emotional, health, basic needs, etc.)



Employee Recognition & Talent Development

- Improve employee morale to ensure better support to students
- ➤ Develop employee talent


