- Informed the Council that a new Administrative Assistant, Antonio Trink, is now working in the Academic Senate office. The previous assistant, Kyle Dang, was bumped due to layoffs.
- Announced that Beth Cataldo is resigning as secretary of the Academic Senate due to a new fulltime assignment that she has taken on. The Senate will need to elect a new Secretary at the first meeting on January 27.

B. 1st Vice President Edgar Torres:

- Reported that he has been promoting committee vacancies with flyers at various campuses and plans to continue advertising. The response is still minimal from the non-credit faculty.
- Informed the Council that he attended the public safety workgroup, where they discussed the Clery Act and how to inform the community about offences that have taken place on campus.

C. Secretary Cataldo:

 Discussed her recent assignment: As Special Assistant to the Chancellor, she will coordinate efforts among SFUSD, the City of San Francisco and CCSF to come up with a plan on how to double the number of high school graduates who complete a degree or certificate by the time they are 25 years old.
