IV. Public Comment

- For those in need of respite, the CCSF Horticulture Department recommends a visit to the Filoli gardens, open Friday and Saturday.
- Note was taken of news of a financial aid scam that involved several area colleges.
- Upcoming Music Department Recitals were announced.

V. Officers' Reports

President Fred Teti reported: (see Appendix A for full report)

- The removal of the word "counselor" from the CalWORKs job title is still being discussed.
- It has been recommended that the Executive Council approve a request for travel funds for upcoming events while a more thorough Executive Council budget is developed.

First Vice President Karen Saginor reported: (see Appendix B for full report)

- Assemblyman Bonta introduced AB 1942: Fair Accreditation for California Community Colleges Act. The main components of the Act include greater transparency, accountability, fairness, due process, and integrity on the part of the accrediting agency.
 - o The Federal Government has only nine standards that represent the minimum standards every accrediting agency must use. These minimum standards do not include the ACCJC's section on governance. This section on governance has been added by ACCJC.
 - o AB 1942 will state that accrediting bodies will use the nine federal standards for California community colleges. Any additional standards will have to be approved by the Board of Governors.
 - o Accrediting bodies will be subject to the Bagley-Keene Open Meeting Act. This act is similar to the Brown Act and will require transparency and accountability, including requirements for open meetings, published minutes, and storage of all records for ten years. Many of the documents that are today listed as secret will become public.
 - o Community colleges will be able to select the accrediting body which will evaluate them. Because law trumps Title 5 regulations, this will remove the requirement that community colleges use ACCJC.
 - o An appeals process will be provided that involves a third party.
 - o If passed this year it could become effective January 1, 2015. It is not retroactive.
- Three additional bills that could affect our accreditation status have also been introduced.

VII. Unfinished Business

A. Accreditation Update

1. Reports from the Accreditation Institute

Accreditation Attendees reported out:

- Eight faculty members attended the Accreditation Institute. None of the CCSF administrators attended. The faculty members divided up the sessions to make sure all of the sessions were attended. Notes from the sessions are online. There will be a forum for faculty to report on what was learned.
- There was not enough discussion of the new proposed accreditation standards. A comparison of the current standards and the proposed standards is online.
- Faculty attending the Institute also met with Beth Smith and John Freitas from the ASCCC to discuss CCSF needs. One possible means of gaining greater representation in the decision-making could be to create co-chairs of key committees.
- In several sessions there seemed to be an assumption that the college ALOs had corresponding and equal-stature faculty as an associate.
- The new accreditation standards represent a move from evaluating college processes to evaluating student learning outcomes.

- Several colleges received acclaim for receiving improved accreditation statuses.

Steven Brown

C. Education Master Plan Update

Wendy Kaufmyn:

- A second round of strategy sessions is taking place this week.
- The plan to include faculty facilitators and public participants through discussions and worksheets on the EMP needs improvement. Faculty need more time to work with the material before leading public worksheet activities. Some of the discussion material includes data that the faculty do not agree with.
- The critiques of the data included in the environmental scan have not been addressed. Large amounts of raw data have been placed online. One suggestion from the Voorhees Group was that faculty be recruited to parse out the data.
- Clear responses to questions about decision-making processes have not been provided by Administration.

D. Collegial Consultation Agreement

Karen Saginor:

- The Collegial Consultation Agreement has been restructured to remove repetitive information. The Agreement outlines a process in which decisions made rely primarily upon the input of Faculty. Suggestions are needed to clarify the consultation process. We would like to vote on this next meeting.
- The Agreement will remove the word "first" from the document, as there are several instances when the Academic Senate would not go first to the Chancellor.

VIII. New Business

A: Preparation for the Bipartite Committee on Graduation Requirements Rosario Villasana:

- Your packets for the upcoming Bipartite Committee were in the mail.
- B. Proposal from Education Policies Committee: AP/IB/CLEP Exam Scores Deanna Abma:
 - The Education Policies Committee is working to clarify CCSF's policies regarding the acceptance of these exams for college credit.
 - The recommendation of the Academic Senate for CCCs is based on a mapping of the Exams to Title 5 requirements and represents a floor for CCSF to base their own policies on.
 - Concern has been expressed that students who receive CCSF credit for Exam scores then are required to retake the course when the transfer institution does not accept the score. This

- happens more frequently when students are attempting to use the AP score to replace a core course for a major.
- A proposal will come before the Academic Senate. If accepted, the proposal would be presented at the Fall Bipartite meeting.
 - D. Proposal from Education Policies Committee: Time Limit on Late Withdrawal Requests

Deanna Abma:

- CCSF's current practice on Late Withdrawal Requests is to allow students two years to file a request. This practice needs to be put in writing. Title 5 does not set a specific time limit.
- The suggestion from the CCSF Attorney and one of the student representatives is to allow students six months to file a request for a late withdrawal. Students outside of the six month window could appeal for a waiver of College regulation.
- Concern was expressed that shortening the time allotted was unnecessary. It placed unnecessary barriers to student success.
- It was also recommended that the written policy include a reference to the process for waiving College regulation.

E. Recommendations for Lottery Money

Susan Lamb:

- We have two sets of lottery money available for funding requests identified in Program Review. One set can be used for supplies that cost less than \$500.00. The other set can be used to fund larger departmental needs.
- The Automotive Department has specific requests that are necessary for them to meet their accreditation requirements. These items have been given priority.
- This money is available for spending for this semester.
- Because these items, according to Title 5 and AB 1725, fall under academic and professional matters, feedback on prioritizing and approving this spending is needed from the Academic Senate.

Concerns Expressed:

• CCSFs current practice is to send Program Review budget requests through the faculty-elected Department Chair Council. That body has the expertise to make these recommendations.

IX. Reports

A. Transfer Issues Committee: Proposed New Academic Renewal Policy

Donna Hayes:

- CCSF's Academic Renewal policy is under review. Currently CCSF allows for Academic Renewal under two circumstances: (1) once a student completes 12 units with an average GPA of 3.0 or (2) once a student complete 24 units with a GPA of 2.0. The proposal is to add a third option: once a student completes 18 unites with a GPA of 2.5.
- Title 5 requirements do allow for this option.

B. Enrollment Management

• Several different strategies are both in effect and under consideration.

- Post cards are being sent to zip codes identified as having high potential for student recruitment. There is some concern that the expertise of CCSF faculty in identifying such neighborhoods is not being given consideration.
- The Summer Semester calendar is being designed to capture more university students.
- How to meet an Enrollment Productivity goal of 17.5 across the college are also under discussion.

X. Open Forum

- Concern was expressed that Administration might need some clarification on the Academic Senate resolution approval process, namely that simply making a presentation to the Council is not the same as our having approved a resolution.
- Advice was shared on getting copies made more efficiently by emailing the originals to the copy center in advance.
- Questions were raised regarding how to identify clearly the roles of the Academic Senate and the Department Chair Council. Los Angeles City College has merged their two corresponding bodies.
- Information was shared regarding an assignment of counselors to centers at least part time.
- In two weeks we have Bipartite: please look through your Bipartite packets. Don't lose them. And the week after that we have a council meeting 3/12. We are trying to move that meeting to the Mission Campus to make up for the move to this campus for this meeting.
