X. Reports

A. SLO Update – Kristina Whelan

- Kristina gave a summary of the reporting from the Spring 2014 semester
- Our CQI Continuous Quality Improvement is heading in the right direction. 75% of the courses are at stage 5. Programs are showing 44% in CQI. Counseling at 100% CQI. Administration is now up to 52% CQI.
- The college needs to be better informed about the 3-year benchmark.
- The challenges: SLO committee would like more robust assessment at the Program Level.
- Some faculty are incorrectly writing stage 5 completion in one semester and then stage 2 in the next semester for the same SLO. You can't GO BACK once you reach stage 5.
- PLOs are due every semester.
- "Get It Done Day" will return and the workshops helped to get reporting numbers up.
- Assessment websites should be updated.
- SLO Programs that do not have Degrees nor Certificates do not need PLOs.

B. Enrollment Management – Susan Lamb

- We are currently at 17 20% down in student enrollment.
- Other colleges are experiencing enrollment issues. Some are down 15%; the average is 5 10% down.
- Her office checks numbers on a daily basis.
- She is going by the contract with courses that are less than 20 students, she is leaving it to the discretion of the School Deans as to whether they will be cancelled. There are 1200 sections that have less than 20 students. Trying to look at the courses in terms of 5 or 10 students pedagogical issues to be looked at. Other sections offered and other seats available? Is it the last course in the sequence?
- We are cancelling only a tiny percentage of course offerings. We try to look at courses individually. They look at special situations: Honor classes, CTE, pathway courses, etc.
- Susan will talk to Virginia about closing enrollment office at John Adams at 4:30pm.
- We have added in more sections of lower level Math and some English.
- Most Pathways classes are enrolled and continuing. Only a few have been cancelled.

C. Student Health Services – Becky Perelli

- Becky Perelli outlined the steps taken to develop the Student Services overview of all health services for students.
- Six quick points to share. Student Services overview (developed with Samuel Santos) of all health services for students. She needs input and feedback as to whether it is useful and helpful.
- We have a brochure going to print soon and could be posted online.
- As of last semester our mental health providers have assigned themselves to various departments. Please check to be sure no department is left out.
- Mental Health Equity: Accreditation standards state we must provide students equitably and student mental health is what she looks at for that equity.
- Kognito Online trainings to learn about students at risk. There are 3 modules for faculty and staff to look at and study. It can be used for INDEPENDENT FLEX credits. You will earn Certificate of Completion when you finish the module.
- Green sheets on support groups. New one starting on trauma education. Begins the week of the 15th of Sept. They want feedback and input.
