VII. Unfinished Business

A. Administrative Retreat Rights

Resolution 2014.09.03.04 Administrator Probationary Faculty Status

WHEREAS, before any person is hired as a classroom instructor, counselor, or librarian, that person's qualifications and abilities to instruct, counsel, or serve as a librarian to students should be assessed by persons with expertise in the appropriate discipline but no such assessment is currently conducted during the hiring of administrators; and

WHEREAS, Education Code section 87458 directs community colleges to establish probationary faculty rights for administrators according to procedures jointly agreed to by the administration and the Academic Senate and CCSF has such a procedure in place as Right to Faculty Status for Administrators, a mutual agreement between the Board of Trustees and the Academic Senate; and

WHEREAS, in Spring 2013 the officers of the Academic Senate brought the current procedure to the attention of the Interim Chancellor and commenced discussions for revising it with the administration (including the Special Trustee, the Interim Chancellor, and the Associate Vice Chancellor of Human Resources) but the administration chose not to continue those discussions; and

WHEREAS, in Spring 2014 the Academic Senate brought the current procedure and the discussions from last year to the attention of the current Chancellor and Vice Chancellor of Academic Affairs but the current administration did not choose to discuss possible revisions to the procedures; be it therefore

RESOLVED, that the Academic Senate urge the administration to comply with Education Code section 87458 and with District policy by adhering to the current Right to Faculty Status for Administrators for establishing probationary faculty rights for administrators unless or until it is formally revised by mutual agreement between the Academic Senate and the Board of Trustees acting through its representative, the Chancellor; and be it further

RESOLVED, that the Academic Senate urge the administration to pursue revising the Right to Faculty Status for Administrators in mutual agreement with the Academic Senate to ensure that a suitable assessment of the qualifications to serve as a faculty member is integrated into any process that results in the provision of probationary faculty status to any administrator who has not previously served in a faculty position at CCSF; and be it finally

RESOLVED, that the Academic Senate urge the administration to refrain from any action that might mislead any administrator into expecting probationary faculty rights that have not been appropriately established.
