A. Accreditation Update – Self-Evaluation update and Status of the Standards.

- Both Faculty and Administrators are working diligently to salvage IIIB. It is in much better shape. The Status of the Standards is online on the Senate website and it captures the conversations that have taken place as to whether we meet particular Standards and Substandards.
- Chancellor changed the status of some Standards that the team felt that we did meet. On Monday, Sept. 29th, the entire day was spent going over all of the findings of each Standard and any Actionable Improvement Plans standard had been questioned. Invited Admin cochairs who were all present. Some of the Standards were discussed at length and were returned to a "meets this Standard". The Chancellor said he would accept the vote of the AS for some of the Standards that are a 10+1 to be discussed in today's meeting.
- The document titled "What Must Be Discussed" is current as of 5am this morning. Included on the WMBD are current Improvement Plans and anything that includes what we should do to meet the Standard. We will vote on a general Resolution for each of the standards. Editing teams will have until midnight on Friday to be sure that their Standard meets in what we vote on here in this meeting.
- Standard II.A.1 Editing team we meet this. AQT says we partially meet this. Also changes to Standard II.A.2.h. as well. Department of Education regulations need to be followed as well as ACCJC Standards. A special meeting will be called to discuss some of the individual changes.

- A rough draft is available on Google Docs and they need input. This will be done in the same fashion as the Self-Study process open and transparent.
- We need to build an infrastructure to make improvements as to how to move the needle on the achievement gap. The funding requires that we show data on this and update it every year.
- Data is being gathered from the State Chancellor's office and Banner.
- Comments from Senate members on inaccuracy of some of the data and to be certain we are assessing the correct data.
