## VIII. New Business

A. Department Reorganization Proposal – Carole Meagher, Steven Brown, Fred Teti

- Fred Teti provided background on the relationship of Academic Senate to Department Chairs.
- There are should be no controversies between senates and unions. The Academic Senate’s purview comes from Title 5. Unions focus on wages and working conditions.
- CCSF is unique in that we have two Faculty unions, one that is advisory.
- The purview overlaps most frequently cited are in areas of performance evaluations and tenure review.
- Last year, VCAA Lamb criticized the AS President for deferring to the Department Chair Council on the 10+1.
- Interruption of the meeting to bring news from an email from Darlene Alioto – President of the Department Chair Council with the subject line: The DCC has reached a tentative agreement with the restructure of the departments. (A Council member reads entire email aloud.)

Dear Colleagues:

The DCC has reached a tentative agreement with the District on the restructuring of the departments at City College. The District will be providing you the details of the restructuring soon. There has been much discussion in our community about the District’s restructuring plans. I am writing to provide the DCC’s perspective and to underscore our shared interests as this process moves forward.

The District has long made clear its intent to “re-structure” City College, starting with early plans to “re-organize” that would have completely dismantled the department structure. The DCC has steadfastly opposed restructuring as

unnecessary and contrary to the interests of the students and faculty. The DCC did not propose, and does not want, any change to the department structure. We have repeatedly informed the District of our fundamental concerns about all of this.

The District, however, has insisted that re-structuring is going to happen, and that it had the right to do so unilaterally. In response, while maintaining our underlying position that the District had not demonstrated that restructuring was in the best interests of the City College community, we asserted that the District must bargain with the DCC over the structural changes themselves, not just the effects of the changes. Aside from its legal underpinnings, that assertion was based on our belief that if restructuring was going to occur, we had a responsibility to exert our bargaining rights in an effort to improve the District's restructuring plan.

During the course of many months of discussions with the District, we have consulted our members and have sought to act in the best interests of our students and the College. We also have made very clear to the District that any agreed upon re-structuring would necessarily have significant effects on faculty and the DCC expected the District to meet all of its obligations to address faculty concerns and to meet its obligations to bargain over effects with AFT 2121. DCC members share with all faculty an interest in working as much as we can to ensure that the quality of education we provide our students is not diminished by these changes.

We feel that the restructuring we have tentatively agreed to is significantly improved over what the District proposed – and planned to implement – before the DCC pushed for the substantial changes that eventually were made. The “re-organization” plan adopted in 2012 would have merged or cut our 61 departments down to 7. As recently as this past summer, the District's proposal would have reduced the number of departments by 10 and significantly disrupted many other departments. Under the agreed-upon restructuring, there will be 56 departments; 37 departments will remain completely unchanged; and we believe that, as a whole, the mergers and splits that will occur will be substantially less disruptive than what the District had planned.

These improvements did not address all of the DCC's concerns. There are aspects of the restructuring with which the DCC strongly disagrees; and, we have not wavered in our underlying position that there is no demonstrated need to make any of the changes the District has insisted must be made. We could not, however, ignore the clear indications of what the District was going to do. Therefore, we worked at the bargaining table to minimize the disruption these changes will cause.

The members of the DCC intend to work with all faculty in the months ahead to keep our students' needs at the forefront and to maintain our excellent programs as the District's re-structuring process moves forward.

E. Arming CCSF Police Dept. – first read – Wendy Kaufmyn

**Resolution 2014.12.10.08      Resolution Against Arming San Francisco City College District Police Department (SFCCDPD)**

Whereas, the loss of Alex Nieto in April 2014 at the hands of the San Francisco Police Department was a tragedy which deeply affected students, faculty and staff of CCSF; and

Whereas, the incidents of March 2014 showed the CCSF community that students can be injured, even with non-lethal weapons such as pepper spray and billy clubs; and

Whereas, the global press is raising concerns about the increased militarization of American police forces; and

Whereas, numerous statistics show that young men of color are disproportionately at risk for experiencing violence at the hands of police; and

Whereas, CCSF’s student body is comprised of 46.5% males; 9% African-Americans; and 22% Latinos;

Resolved, that the Academic Senate of City College of San Francisco urge the Board to decide against arming the SFCCDPD with lethal weapons, in the interest of the safety of our students.

F. Returning the CCSF Board of Trustees – Wendy Kaufmyn

**Resolution 2014.12.10.09      Resolution to Recommend that the BOG restore CCSF BoT Now**

Whereas, in the recent trial of SF City Attorney vs. the ACCJC, the State Chancellor testified under oath that the only reason he asked the Board of Governors (BOG) to remove CCSF's elected trustees and replace them with a Special Trustee With Extraordinary Powers (STWEP) was because the ACCJC president led him to believe that it was the only way to save the college; and,

Whereas, the State Chancellor further testified that if he knew then what he knows now he would not have followed the ACCJC president's suggestion for the state take-over; and,

Whereas, the State Chancellor expedited this state take-over despite the fact that it required the BOG to pass an emergency resolution that changed the criterion for this action from financial issues to accreditation issues; and,

Whereas, CCSF's CFO testified that the state take-over had no justification based on finances since City College was far from bankrupt, had appropriate levels of financial reserves throughout the Great Recession, had just passed a balanced budget and an 8-year stability plan, and had not asked for a loan from the state; and,

Whereas, the STWEP was appointed in order to regain CCSF's accreditation and yet ACCJC commissioners testified that they voted to terminate CCSF's accreditation largely due to his presentation to them; and,

Whereas, no other college requires 9 months of training to seat a democratically elected Board; be it therefore

Resolved, that the Academic Senate direct its president to write a letter to the State Chancellor and the BOG to recommend that they immediately restore the authority of CCSF's democratically elected Board of Trustees for all of the above reasons.
