#### **IV.** Public Comment

# V. Officers' Reports

President Marrujo-Duck reported:

• There has been more discussion of a Technical Assistance visit by the ASCCC. This time it comes from the Office of Institutional Effectiveness who wish to have the team of ASCCC mentors pay particular attention to the Fan Five coordinators (Basic Skills, SSSP, Equity, SLO, Pathways), to help the institution become more effective. This still does not cover how our governance structure works. LMD sent a link to this today and will be up for a discussion in a future meeting.

# First Vice President Villasana report:

- Five committees responded to the survey not great.
- Work on re-envisioning of how the committees' work can be inherent in process of the governance of the college. Volunteers are minimal and there is not much recruitment success.
- Councilmember input: There is a huge drop in involvement of faculty because there is no communication tool between faculty and staff. No city currents, etc. Most are expected to read an ineffective email with low content.

#### Second Vice President Monica Bosson

- The officers have not had Collegial Consultation with the chancellor in several weeks.
- She attended the Starfish presentation and saw some great ideas but it is a huge amount of work. If you think your inbox is full now, it's all done by email. It was the Friday before Spring Break. They couldn't tell us how much it cost. It might be a done deal because CCSF is a pilot-program Hobson putting up this but no one knows how much it will cost.
- She has been working with Simon Hanson and Anna Asebedo on the Program Review Committee to make our Program Review link up with the budget so that it has more teeth. The entire committee is working to make it an easier process.
- Leslie Simon, our nominee for the Stanback Stroud Diversity Award did not receive state recognition because the reward was pulled. There were only two nominees total from across the state and the minimum was three.
- State ASCCC now has a resolution upcoming at the Plenary recommending that all colleges form an Awards and Recognition State Committee.

- The framework is the Masters and the Non-Masters list on the ASCCC Disciplines List and whether this particular field is one such to add to the non-Masters list. It's a question about the entire discipline.
- David Pieper in attendance to speak to this resolution. He objects to the notion of the faculty minimum qualifications to have a Bachelor's degree only as there are many masters degree programs in this area already.
- The ASCCC committee that worked on this resolution researched it for a very long time. It is uncertain as to how many graduates there are of these programs.
- Many CTE programs require more field experience rather than an advanced degree and thus an AA plus 6-years in the field or a BA with 4-years in the field, etc. In BEMA, for example, teaching the production courses do not require a Master's Degree.
- G. Changes to Senate ByLaws Francine Podenski
  - The workgroup focused on the bylaws because they are the easiest to update. The AS Constitution is very difficulty to change.
  - Applicants who teach evenly-split loads in 3 different departments would have the explicit option to choose which they represent when they run for Executive Council.
  - Article II is new to make explicit that we must follow the Brown Act.
  - Article III states that meetings are guided by Roberts Rules of Order, Revised.
  - Unlimited committees would not have to have a simple-majority quorum.
  - Revised draft will be discussed and voted on at April 22<sup>nd</sup> meeting.
