## III. Welcome and Introduction of Trustee Tom Temprano

The Executive Council welcomed Tom Temprano, new member of the Board of Trustees, to the meeting. Trustee Temprano introduced himself to the Executive Council, spoke of his experience as a community college graduate, highlighted his political experience and engagement, and indicated that he was galvanized by the recent reaffirmation of accreditation and announcement that Free City College would proceed.

Executive Council members highlighted several issues of concern, including:

- Possible impact of the Balboa Reservoir question
- Accountability to voters' approval of funds for the Performing Arts and Education Center
- Proposed relocation of services from Gough Street to the MUB and its impacts on CCSF programs, especially in CTE.

## IV. Officers' Reports President Liang reported that:

- The college-wide celebration for the affirmation of CCSF's accreditation would be held March 3, 2017, in the Smith Hall cafeteria, with required RSVP.
- She was collaborating with Jill Kersey, Kristina Whalen, and Kristin Charles on the citywide accreditation celebration.
- Bookstore services would continue 1 day a week at each center and dialog on this issue will continue.
- The curriculum technical assistance she had requested would occur at the March 8, 2017 meeting of the Curriculum Committee.

# First Vice-President Teti provided a written report (Appendix A)

## Second Vice-President Staff reported:

• None at this time.

## Secretary Arceneaux reported that:

- The Senate officers would meet with representatives of the Foreign Languages Department and the administration regarding the Language Center.
- The Senate officers had met with Lani Battiste regarding the prevention of hate speech on campus in the current political climate, and that she would attend the next meeting to speak on this issue.

## V. Public Comment

- It was announced that student club leaders were required to have a minimum of 6 units at Ocean Campus and maintain a 2.0 GPA, the former criterion negatively impacting programs split between several locations.
- Gratitude was expressed by faculty from the centers for the opening of the various bookstores, though the issue is not resolved.
- More lead time was requested for large functions like the accreditation celebration.
- Converting MUB classrooms to administrative use is bolstered by state regulations that do not consider evening use of classrooms; this issue needs broad exploration.
- The MUB classrooms potentially to be converted contain special equipment necessary to CTE courses, and the funding voted for the building was specifically for these programs.
- Neither department chair in MUB was contacted about loss of classrooms.
- The repeatability question needs to be reopened, given Board interest and developments at other California Community Colleges.

# **B.** Compressed Calendar

Executive Council member Alexis Litzky and AFT 2121 President Tim Killikelly gave updates pursuant to the discussions at the preceding Executive Council meeting.

Faculty feedback:

- Where would a workgroup on this issue, perhaps with some release time involved, belong?
- Certain issues (loads, working conditions, and the calendar itself) are union prerogatives.
- Incomplete information renders making an informed, coherent decision difficult. Basic information needed to move forward is lacking.
- Per the RRP, items that are clearly 10 + 1 should be recommended by the Senate and pass on as informational items.
- Perhaps a joint effort of AFT and the Senate is necessary.
- The new Facilities Master Plan must be solidified and adequately considered because of implications for rooms and scheduling.
- The impact of Free City College is an important variable not yet considered at meetings on the compressed calendar.
- A clear cost–benefits analysis for the transition needs to be conducted.
- The college community needs clarity about the effects of block scheduling.
- It is unclear how much flexibility would be afforded to departments disproportionately impacted by a compressed calendar.

## C. Free City College Program Update

President Tim Killikelly and Alisa Messer of AFT 2121 provided a brief update on the status of Free City College. The Board of Trustees approved the compromise packed on Thursday, February 9, 2017. Grants are significantly reduced. AB 540 is included but there is a lack of clarity regarding DACA students, and those not eligible for DACA.

# **Committee Update**

Same as last time: The next round of term-expirations will happen at the end of May. I'm trying to figure out how far in advance I should (1) ask the soon-to-expire folks if they seek reappointment and (2) advertise the upcoming vacancies.

## **Education Policies Committee Report**

Ed Policies continues to work on improvements in procedures and Catalog language. Recent developments include

• Time Conflict Reconciliation Procedure: We are very close to approving the new Time Conflict Reconciliation form and concomitant Catalog language. The new form will bring us into Title 5 compliance as cheaply as possible. Nonetheless, we expect that faculty will be less willing than in the past to sign off on time conflicts.

- Certificate Requirements: At our next meeting we will vote on a proposal to impose a 20% residency requirement and a "C-or-better" requirement on CCSF certificates.
- G.E. Area G Waiver: We voted to propose that the College permit any department offering a degree whose major requires at least 27 units to waive the G.E. Area G requirement. Conversely, they may not waive the requirement for majors with less than 27 units. The Catalog would list the eligible majors and we would phase out the petition form. This proposal will come to the Council in March.
