VII. Unfinished Business

A. Public Safety Management Study Report & Discussion about Arming Campus Police

Chief Andre Barnes gave a PowerPoint overview of the last 9 months' developments around questions of campus safety, during which, with the help of consultants, an in-depth look has been taken into overall service and quality improvements to meet industry standards. Chief Barnes expressed confidence about a good relationship between the CCSF Police and the CCSF community, mirroring a national trend on campuses that does not necessarily apply to municipal police forces. He expressed concerns that, in the event of an active shooter on campus, SFPD may not be able to respond quickly enough to prevent the loss of life. His overall opinion is in favor of arming the sworn officers on campus, including with bodyworn cameras and less-lethal force options like Tasers. In this discussion, he urges the college community to establish any comparisons to peer community colleges and local colleges such as SFSU, UCSF, and USF, as opposed to SFPD.

Executive Council and Community feedback:

- Concerns were expressed about the representativeness of the survey on campus safety, due to a very small number of respondents on an issue about which many people feel very strongly. Chief Barnes indicated that, as important as community input is, he feels the decision should be driven by people with law-enforcement expertise. He himself would respond, on a survey, that he does not want guns on campus, but believes it is an appropriate move from his professional background.
- Student and faculty members of the CCSF community expressed fear that a situation similar to excessive use of force by municipal police forces could arise at CCSF if officers were armed.
- The Associate Students and AFT 2121 have taken a strong position against arming the CCSF Police.
- Several individuals expressed a desire to see CCSF not conform to what others are doing, but lead them in a new direction away from arming campus police.
- A desire was expressed to see before-and-after data about the positive or negative impact of implementing arming campus police at other institutions.
- Today's automatic and semi-automatic firearms make it possible to kill many people in a few seconds; every second counts.
- Do we want the possibility of hired security contractors being imposed, instead of arming the officers who have worked among us for years and know us well?
- The Academic Senate is bound by a 2015 resolution against arming our campus police; this resolution would have to be rescinded for the Senate to change its position on this issue.

VIII. New Business

A. BP / AP 2.17—Discussion

First Vice President Teti gave an overview of the current and proposed policies and procedures about smoking on campus. The group consensus was in favor of maintaining, and actually enforcing, designated smoking areas on the campus, per the current policy, edited as needed for greater clarity.

Executive Council and Community feedback:

- It is unreasonable to send large numbers of people out to the street to smoke, and will only increase tardiness to classes.
- Would this forbid people smoking in their cars (private or public property)?
- This proposal would set people up for fines they cannot and will not pay.
- The adoption of a smoke-free policy at SFSU led to massive, complicated ticketing and enforcement issues.
- If the current policy cannot be effectively enforced, which it has not been, then how can something even more ambitious be reasonably considered, especially when the campus police have much more pressing issues, such as dealing with threats and deciding whether to arm themselves?
- Numerous individuals said that properly enforced designated smoking areas seemed completely reasonable to them.
- The Senate members of the PGC suggested drafting a resolution to submit to the PGC that would clearly articulate the desire to maintain, and properly enforce, the current policy.

B. ASCCC Spring 2017 Plenary Resolutions

Resolution 2017.04.05.04 Keep 3.29.2017 Language for Repeatability Resolution

Resolved, that the Repeatability Resolution being submitted by the CCSF Academic Senate to the ASCCC Spring 2017 Plenary (April 20–22, 2017) keep the original language of the March 29, 2017 version:

Assessing the Impact of Repeatability on Student Success (DRAFT TO BE SUBMITTED TO ASCCC SPRING 2017 PLENARY) March 29, 2017

Whereas, the changes in repeatability regulations adopted in 2012 were austerity measures in response to concerns that the State's subsidizing repeated courses was untenable during the erstwhile financial crisis;

Whereas, the 2012 changes to the repeatability regulations have had a deleterious effect on enrollment in diverse classes and affected departments; and

Whereas, a more comprehensive analysis of the impacts of the changes in the regulations may be available from community colleges around the state, including the effects on student success and achievement in affected disciplines;

Resolved, that the Academic Senate for California Community Colleges collect information from local senates about disciplines adversely affected by the 2012 repeatability regulations and present the findings at the Spring 2018 ASCCC Plenary; and

Resolved, that the Academic Senate for California Community Colleges work with the appropriate system partners to explore ways to increase repeatability options needed for student success, particularly in disciplines where responsible pedagogy requires quality practice and repetition learning.

Program Review Prioritization Meeting Report

This meeting was not what I expected. First, only the Academic Affairs deans were present. I asked if Student Development, Finance and Administration, Institutional Development, and the Chancellor's direct reports had their own meetings but the deans I asked didn't know. I thought the deans would go through the entire list and dicker. Instead, the deans came to the meeting with their top five picks from among all their units' program reviews. Each request was given some quick sunshine, the deans all rated them on a 0–5 scale using clickers, and the total was recorded. Presumably the requests were later all ranked according to those totals. During the 3-ish hours I was present, there was no point at which the rankings were examined holistically to see if the College's needs were being broadly served. (For example, none of Ed Tech's requests made it onto my dean's top five, not even the one she asked for herself.)(Well, she's a librarian.)(So what will Ed Tech do with no money for our software licenses? Close up shop?) I can only hope that such a holistic review will take place among the vice chancellors.
