#### IV. Introduction and Welcome: Trustee Shanell Williams

The Council welcomed newly elected Trustee Shanell Williams. Trustee Williams indicated that the Board of Trustees was handling many important issues at this time, including the search for a permanent chancellor, the implementation and impact of Free CCSF, and issues

around facilities (Facilities Master Plan and the Performing Arts and Education Center). She stressed her commitment to helping rebuild the college and foster access and enrollment. Trustee Williams believes that, as a CCSF graduate, she brings a historical, insider perspective to the Board. Executive Council members brought two issues of great concern to them: maintaining classroom spaces in the MUB and in Batmale, and proceeding with the Performing Arts and Education Center (PAEC).

# V. Public Comment

- The Board of Trustees needs to ask for actual, hard, independent figures instead of relying on less formal estimates or assertions from various administrators.
- A request was made by AFT 2121 to find a way to keep BCST 140 from being deactivated in Fall, 2017. The Course Outline of Record is now in and things are in order for Spring, 2018.
- There will be a party for retiring faculty on Thursday, May 4, 2017.
- The Asian Coalition Scholarship Dinner (chairs: Monica Liu and Lisa Romano) will be held Friday, May 5, 2017.
- Faculty were encouraged to attend commencement ceremonies this year, to support graduating students.
- Music Faculty members Lenny Carlson and Madeline Mueller will give a concert at 11:00 a.m., Tuesday, April 25, 2017, in ARTS 133.

#### IX. New Business

#### A. Noncredit Presentation

Monica Liu, Elizabeth Leiserson, Ophelia Clark, and Rudy Padilla presented extensive information of value to instructors in credit programs to have a better grasp of noncredit offerings and program at CCSF. They reported:

- CCSF has one of the largest noncredit programs in California.
- Career Development & Placement Center (CDPC) funds at the same rate as credit; the other 30% of noncredit courses are funded at a lower rate.
- There are 55 noncredit certificates in the 2016–2017 catalog. Between 450 and 500 noncredit certificates are awarded at CCSF each year.
- All noncredit courses are open-entry and open-exit. Positive attendance is kept per hour, not on the census. PARS roster sheets must be submitted every 2 weeks, and the processing is quite complicated.
- The largest demographic difference for noncredit is that the students are generally older than in credit courses.
- A very large number of CCSF noncredit students live in the Ingleside district.
- The CCSF Noncredit Business program is the second biggest noncredit program at the college and the largest CTE program overall.
- Letter grades are required in noncredit courses; P/NP grades are not used.
- Cuts at the college are making it increasingly difficult, and sometimes impossible, for students to finish a noncredit certificate at one center; this access issue is particularly relevant to noncredit students.
- Overall, although noncredit applies many of the same standards as credit, it cannot be made like credit, because it was not designed to be that.

# D. Code of Student Conduct and Student Discipline Process Presentation

Andrew King and Rita Tuialuuluu gave an overview of the Code of Student Conduct and the processes associated with it. They urged all faculty to utilize the appropriate range of sanctions in progression, and to document every infraction of the code in order to create information about students' patterns of behavior across other classes and all the centers and sites. Although deans may be invaluable for immediate handling of an infraction, the proper paperwork and reporting should still be submitted. In the event of a public violation of the code, as in a classroom context, the student has effectively waived his or her right to a private response on the part of the instructor.

# E. Assessing the Impact of Repeatability on Student Success—Resolution to be Submitted to the ASCCC Spring 2017 Plenary

#### F. Prerequisite Enforcement Methods and Disparate Impact

# **Resolution 2017.04.19.05** Prerequisite Enforcement Methods and Disparate Impact

Whereas the establishment and enforcement of prerequisites is a valuable and necessary process for promoting student success, and

Whereas Title 5 Section 55003(o) enjoins that colleges provide for enrollment to be "permitted pending verification" (with involuntary withdrawal if necessary); and

Whereas the current mandatory computer enforcement of prerequisites at the time of course registration has resulted in a multitude of students losing access to courses they

are qualified to take in some disciplines; and therefore "constitute unjustifiable obstacles to student access and success" [CCSF Board Policy 6.15]; and

Whereas in the case of CCSF Economics courses, research has documented disproportionate impact, showing that "African-American, Latino, veterans and older students are more likely to be denied entry in classes for which they are qualified to enroll," a preliminary analysis of Foreign Languages shows disproportionate impact, and it is possible that similar results pertain to other disciplines that have not yet been researched in detail; and

Whereas prompt, effective action is required to avoid depriving large numbers of additional students from access to courses that they will be qualified to take in Fall 2017 and future semesters therefore,

**Be it resolved** that the Academic Senate recommend development of an alternate process for prerequisite enforcement that removes "unjustifiable obstacles," to be used for specific courses for which significant numbers of students who attempt enrollment would be rejected in spite of their ability to meet the prerequisite (because pertinent data is not in the CCSF registration database) - these courses to be specified by discipline faculty and department chairs; and

**Be it further resolved** that Academic Senate recommend that the alternate process permit conditional enrollment and that the verification of the prerequisite is to be completed by a specified time after the first meeting of the course; and

**Be it finally resolved** that the Academic Senate recommend that a pilot of an alternate process be made available for relevant courses for Fall 2017 registration and enrollment to avoid continuing harm to student access and success.
