#### III. Public Comment

- Sophia Montano, the new student activities clerk in student union, came to give a handout about the RAMS Block Party event everyone is invited to join.
- One Senate member mentioned how nice it was to go to the Sunset district of San! Francisco (sponsored by Gordon Mar), and getting back to the community. Two ECE! classes will be offered there.!
- One Senate member announced a meeting about sustainability factors some related to fire safety. There is an annual ragtime event through the music department, and opera ticket discounts were announced.
- One Senate member wanted an update about IT and a lack of a dedicated MAC specialist in the labs. So far, requests to meet with the chancellor have been unresponsive. Photo, BEMA, Cinema, and BMD will not be able to run courses without this software.
- One Senate member made an announcement of the Holiday Sale which benefits! Scholarships!

## IV. Officer reports

## **President Litzky reported that:**

- She traveled to Newport Beach for the ASCCC Fall Plenary. The overall tone was "okay" considering which most thought was pretty good. It is a disservice to the college that we can only send one person to the Plenary (due to limited professional development funds).
- Some highlights included:
  - A resolution passed to extend the "hold harmless" provision for the SCFF to 2023. This could be a good thing to stave off impacts of performance-based funding without making changes to the funding formula.
  - o Another interesting way of responding to the formula included adding additional categories for points for ESL students.
  - o There was a resolution passed about Equity and that anti-hate and anti-racism should be infused into everything we do. Who and how people participate in executive leadership at the state level is critically important.
- Litzky shared the latest news about what is the projected \$13 million budget deficit, not hopeful about what this looks like for the future. We haven't seen detail about these projections.
- Lastly, President Litzky briefly oriented the Council to the items on the consent agenda.

## First Vice President Hanson reported that:

- There have been a slew of budget committee meetings.
- There is a report and a reference to a FCMAT intervention right now, we have a reserve balance of 5-10%. The concern this year is whether we are spending more or less than we make.
- The administration has said that there is a \$15 million increase (we would spend more than what we put in the budget). The question about this has come forward to the board, and the board has asked whether this was brought to faculty. The answer was that "we will get back to you at the next budget committee."

# **Second Vice-President Teti reported that:**

• The in-progress draft of the mid-cycle accreditation report is on the Accreditation Steering Committee's website. He asked Council members to check on the draft as it is being written and to make sure that what it says reflects the College's reality.

#### **VIII.** New Business

- A. Learning Assistance Center renaming
  - Vita Paramo and Elaine Avrus discussed the process of the renaming of the Learning Assistance Center, which has been around since 1996. A main goal was to rebrand and start fresh to capture more of what we do and capture this in our name and what we offer. They wanted to be sure that this was a democratic process.

# C. Budget and the faculty role

- President Litzky is trying to figure out the best strategy to respond to the information collectively and as an individual serving on the PGC Budget Committee and Academic Senate.
- Currently, SVC chairs the committee with support from AVC Nasser. There are other options. Many colleges across the state have a faculty co-chair or a Tri-Chair structure on the budget committee.
- Some have suggested to shut the school down for a day to discuss the budget.
- President Litzky facilitated a conversation about how we should respond at the budget committee level and in consultation with the chancellor.
- The slide "The Path to 32,000" was shown.

#### **Questions and Comments:**

• One Senate member would note or observe that without partnership with the faculty, and the ability to connect with other resources – and this may cause missed opportunities. Helpful for people to show us "how to do it right," rather than "police us."

- One Senate asked about the line item "continue to shift compensation expenses to Ufund."
- One Senate member responded that in the law that gives us the categorical funds we are supposed to use the funds to supplement not supplant our work.
- One Senate member mentioned how "decrepit" our IT is (banner, registering) and these could help us get more students which could get us more money.
- One Senate member believes that we need to deal with long term structural issues how are we addressing, and what plans can be made to resolve? It might be helpful to mend or bridge the divide between faculty and administrators if the committee was co-chaired by faculty, classified and administrators. Why are there gaps in information?
- One Senate member mentioned that very little attention has been given to revenue sources and fundraising.
- One Senate member expressed that we (faculty) have never been asked about what we think. Cutting classes defeats our only means of earning substantial amounts of money. Are we getting bad information from our administration?
- One Senate member expressed that this seems to be a big mystery. As faculty members, we do not have the power to set the budget. With cuts, how can we be \$15 million in deficit? We have requested information for a very long time, and why we haven't gotten the information is a question we need to continue asking. How can they not know why were in this situation? Be prepared for faculty and department chairs to be blamed. A bipartite situation may be possible to push for.
- One Senate member mentioned that the schedule is out. The same Senate member asked about the possibility of another faculty SERP.
- One Senate member mentioned that we are not \$15 million underneath and one of the things we can unify on is process.
- One Senate member hopes that moving forward that we can find out what other cost measures are being taken and where the other cuts are being made.
- One Senate member asked about whether an independent audit would take place to which the response was that Trustee Lee has responded with the hiring of a controller.
- One Senate member asked whether the bond was included as part of the revenue.

#### IX. Reports, Updates, and Discussion items

# A. Works of Art Committee report

Barabara Lass, along with her colleagues Christian Olmos, Katrina Rahn, and Leslie Simon, members of the Works of Art Committee, report that they were not consulted properly with regards to this year's parking pass. On the front is a fine photo of the Aztec calendar, along with a complete misidentification of the Aztec calendar – two totally different groups of people. That this is an official document of our college is insensitive and embarrassing. It is also disrespectful to indigenous people. The information about this piece of art is on the CCSF website, and it could have taken two minutes to confirm. Is it too late to correct? Can we have the support of the Senate? Should a resolution be passed? We are concerned that the Works of Art Committee be viewed as responsible.

- One Senate member believes we should do "all of the above" and take all steps necessary to correct the hang tags.
- A Senate member supports drafting a resolution with the solution and discussion of the process by which this photo was selected and the committee was not consulted. This action is not appropriate for an administrator.
- One Senate member supports doing a resolution for the future.
- One Senate member suggests that if you write a resolution, it would ensure that ! committee processes are followed in the future.
- One member of the Works of Art Committee suggested a sticker.
- One Senate member suggests that the Chancellor issue an apology.
- One Senate member suggests that we get the LEA (Latin Educator's Association) to request an apology.

# B. RiSE cluster activity

- Process flowchart for proposed certificate awarding was discussed.
- Certificate petition process flowchart with Department Chair Signature required was shown.

• Getting Students "Close to completing degree" petition.

# D. Matriculation & AB705 update

Erlinda Legaspi provided a Matriculation Update:

- Listening subtest was eliminated.
- Matriculation card & ICIF was discussed (elimination of blue and yellow matriculation cards thanks to Starfish).
- Another improvement is that all paper forms are online and communication is direct saves time and running around.
- An update of AB705 was presented, along with AB705 FAQ.
