## I. Call to Order 2:30

#### II. Adoption of Agenda

• A comment was made about the lack of public information about updates of the new CCSF website.

## **IV.** Officer reports

## President Litzky briefly reported that:

- There is still some faculty travel money available. Kim Keenan, Faculty Travel Coordinator, has requested that any out of state travel through September 2020 be submitted before Spring Break to ensure Board of Trustees approval prior to travel.
- The Townhall Workgroup met and explored possibilities of holding a town hall meeting or writing an open letter to the Chancellor. While the Chancellor has declined a large town hall meeting, he appreciated the question that the group

suggested for him to focus on in the last administration report. The workgroup will meet again to form another focus for the Chancellor.

- Regarding the parking permit resolution, Shawn Yee represented the administration and offered an apology to the Works of Art Committee for omitting to consult them. The meeting established positive development in bridge-building among constituencies.
- According to the Chancellor's timeline, we will "wait and see" what the election day on March 3 will bring, and the Chancellor will attend our senate meeting for his report on the following day.

# First Vice-President Hanson briefly reported that:

He has attended many meetings. The highlights are as follows:

- In the last Board Budget and Audit Committee, the Board stressed that the presented items should come from shared governance. The Board also showed frustration when data requested was not available from the administration. It's reported that the summer schedule has been reduced to 50% from the previous summer. Of the 48%, it's allocated to the partnership with SFUSD as already committed.
- The Enrollment Management Committee meeting also met to address the reduced offering of the summer schedule.
- The PGC Budget Committee discussed the actual number that would direct the administration to develop a tentative balanced budget. The proposed FTEF for 2020-2021 would be about 1200, or an approximately 13% reduction. The Office of Instruction will provide the departmental allocation, and the departments will loop back to provide a dollar amount of the class offering to avoid overspending.

# Second Vice-President Teti briefly reported that:

- Education Policy Committee met and approved the proposal for the auto-petitioning of noncredit certificates. The Noncredit Adult Education Committee will continue their discussion.
- The residency requirement in the major will not be proposed.

# Secretary Law briefly reported that:

• She was thankful for the Senate Presidency's time and effort in attending the various meetings and their reports.

- There was a comment about the large number of new members volunteered and were appointed in these committees.
- A question was raised about if alternate members automatically get re-elected in limited membership committees. First President Hanson responded that whenever there's a vacancy an invitation is sent out to the committees and the faculty. It is pointed out that we are committees of the willing, and we try our best to make sure committees are well represented.
- A question was asked if committees reach out to other constituency groups if they were not represented.
- It was hoped that the new website would help to make it easier to keep the committee websites more current.

# A. Board policy review: BP/AP 8.06 Procurement of supplies, equipment and services\*

Although the Board policy is not a 10+1 issue, President Litzky represents the faculty to attend the PGC meeting to present our feedback. A summary from our brief discussion from the last meeting was that there seemed to be too much reliance on the Chancellor in the facility contracts. The following is the feedback from the Senate members:

- A Senate member objected to the sole authority of the Chancellor over the contracts and the practice that his friends were beneficiaries of the contracts.
- A Senate member expressed concerns that the drastic changes in this revised version of the policy and the changes codified the chancellor's unilateral power. For example, the part of the policy where all emergency contracts were to be reported to the board within 30 days was eliminated. Also, there didn't seem to be a recusal requirement for persons who might have conflicts of interest.
- A Senate member questioned if these facility contract conditions made within the education field were the same as those made outside of education.
- A Senate member raised the concern about awarding contracts to the lowest bidder.
- A Senate member would like to see proper oversight to the contracts because the last bond fund seemed to have spent but no buildings were built.
- A Senate member pointed out that the Board policy did state that there should not be any conflict of interests.
- A Senate member acknowledged a strong opposition to these changes from the Senate body based on multiple grounds. Since the last policy change made through PGC explicitly removed some of the oversight requirements and restriction of the beneficiary of bonds to pay for their bond campaigns, the Senate representatives would urge in PGC that the policy should not be passed.
- A Senate member commented about the lack of specifics about maintenance of rental or lease.
- A Senate member pointed out that there was a bond oversight committee.
- A Senate member expressed concerns that the many changes in the Board policy were leading towards making the Chancellor as the sole authority over contracts and encouraging nepotism where a bidding process wasn't required.
- A Senate member commented that the expenditure on renovating Conlon Hall was spent but the venue was not in use for the purpose it was renovated for.
- A Senate member reminded us about what the best interest of our college was. The lack of oversight reiterated the Mayor's comment that we had to put our fiscal health in order.
- A Senate member suggested that we form a work group to write a resolution about the construction issues and concerns about the bonds to the Board of Trustees.
- A Senate member commented that although there was a Bond Oversight Committee, it's rendered useless because most meetings were cancelled.
- A work group was formed with these members: Steven Brown, Ekaterina Fuchs, Marie Osborne, Michele Sieglitz, Rosario Villasana, and Christina Yanuaria.

# VIII. Updates

# A. Website update

- Michelle Simotas presented the new CCSF website, and she clarified that the design of the website was happening with RiSE money but coordinated from the Chancellor's Office.
- The primary way for students to navigate the website is by clicking the buttons on the homepage that lead to degree-seeking and transfer, professional growth, and personal enrichment.
- Once students choose their academic goal, they can explore the different program maps where departments give an overview of the programs and a list of resources related to the program.
- The Personal Enrichment (the name for now) page shows the noncredit programs and the apprenticeship program.
- A Senate member asked if faculty get a chance to preview and edit before the pages are launched so that we get a chance to provide input.
- The response was that there will be time for departments to create content and provide input.
- The soft launch would be open for the first week of March for a couple of weeks.
- A Senate member asked who the page owner would be and if there would be training for department chairs to edit the pages.
- A Senate member asked if there was a page for students to see all the programs/certificates.
- A Senate member asked if there would be a fact-check process for departments to correct inaccurate information.
- A response was made about training for ADA compliance prior to granting privileges to edit pages.
- A Senate member asked if the images with hired models to be our students would be replaced by those with our CCSF students.
- A comment was made that Google Forms were sent out to department chairs in the past 6 months to fill in content for the program pages; however, the team only received 50% of the expected responses.
- A Senate member hoped that there would be a way to get updates on the progress of the website.
- The response was that a small group of non-faculty members from the Chancellor's Office were working on the website, and the RiSE team has worked hard to try to build communication bridges between the contracted webpage writers and the faculty.
- President Litzky has requested Leslie Milloy from the Chancellor's Office to give a presentation of the new website in PGC.

# IX. New Business

# A. RiSE report and program groupings resolution+

Eric Greenfrost and Lisa Velarde came back to provide updates of the amendments of the resolution. This is the second read.

• There are 8 communities to orient students regarding their academic goals.

- A methodology was used as a foundation to group the programs into the communities.
- Some inconsistent terminologies were notices and corrected, such as "major" should be "AA/AS" and "People, Culture, and society" to "Society, Culture, and Social Justice."
- Some programs belong to multiple communities.
- In response to the the first resolved, instead of having a long list of academic goals in the drop-down menu that applicants needed to scroll down in the CCCapplication process, the adoption of the groupings would allow applicants to choose one of the communities where they could still explore their academic interests.

An amendment of the resolution was proposed to remove "the Pathways Committee recommends that" from the first resolution.

# X. Reports and Discussion items

# A. Integrating Institutional and General Education SLO Assessments\*

Craig Kleinman, co-chair of Curriculum Committee and SLO coordinator, and Rachel Cohen, Articulation Officer, joined our discussion.

- The goal is to use and study the valuable data to help inform decision-making effectively at the college.
- Since the GELO assessment process has been changed, there seemed to be some missing parts where we could look into why certain courses are part of that GE area and the inventory aspect of the GE area.
- It would be great if the SLO coordinators present reports to the Curriculum Committee.
- While aggregate reporting is fairly new, one-third of the reporting is not accounted for. A possibility for the future is to also incorporate GELO assessment in the aggregate reporting.
- There was a suggestion to add a checkbox for course outline reviewers and new course outline originators to confirm if they have reviewed the GELO assessment reports. Another suggestion was to form a workgroup that congregates faculty of areas D and F to share their feedback and pedagogical approaches.
- There was a comment that this exercise might steer us from the compliant culture toward fostering pedagogical values and development.

# B. <u>Starfish</u> discussion

Dean Lidia Jenkins and Alicia Fausto gave backgrounds and context of the discussion.

- The license for Starfish product needs to be renewed in June 2021, or a different program will have to be selected.
- There have been reports of mixed experiences and reactions with using Starfish.
- There are plans to coordinate with IT and Office of Instruction to make better use of this tool.
- A Senate member voiced the concern about how training had been rolled out.
- Training videos with step-by-step instructional guides would be posted on the website within this week.
- A Senate member asked if there was any support from the upper administration to continue using Starfish.
- The response was that the administration didn't have a deep understanding of the function of Starfish. More attention was needed from them to ensure a better adoption by the stakeholders and IT support.
- Another response was that funds needed to be allocated to continue using the product.
- A Senate member commented that it had taken a year to get Starfish to work properly despite the time and effort had gone into the program.
