### III. Public Comment

- Covid Relief Measure which could bring more funding for the college is on the docket at the state level per Nancy Pelosi's office.
- No cuts in faculty jobs, pay or classes is being recommended to be added to the AFT agenda; encouragement to promote this at the start of the next Union meeting on March 23 at 3pm..
- An announcement about a CCSF student who has been unable to complete

- A discussion and action on clarifying the role of the Academic Senate in determination of Faculty Service Areas, <u>discussion notes</u> and draft <u>resolution</u>
- Disciplines lists still need to be sorted out through HR; once that happens, the Academic Senate should be part of the approvals process. Current process and timeline is unclear and does not include Senate review.
- One member stated that administration has breached the agreements in our collective bargaining agreement and the timeline to clean this up is not feasible with the looming layoffs. FSA definition and criteria is unclear as is whether these changes are retroactive.
- This is only applicable to those requesting secondary FSAs, not undermining the FSA faculty were originally hired under.
- Discussion ensued regarding resolution urgency, language and implications.
