1. Call to Order 2:32

President Miraglia read the land acknowledgement:

c. Incorporation of DEIAA Language into Faculty Evaluation Forms

Resolution 2024.04.03.4C Resolution Recommending CCSF use "Academic Notice" to replace "Academic Probation"

Whereas on November 29, 2023 the Academic Senate Executive Council passed
Executive Resolution on Decriminalizing Academic Probation Language initiating the convening of a cross-constituency taskforce to replace "Academic Probation" with less carceral language and review instances where the college can change language and review policies and procedures as they relate to students' academic progress; and

Whereas, the taskforce has been meeting since December 2023, has developed a work plan to make updates and changes to Academic Probation by the end of May 2024 as outlined in this workflow document; therefore, be it

Resolved that ASEC endorses the taskforce, comprised of students, faculty, classified professionals and administrators, recommendation that CCSF change "Academic Probation" to "Academic Notice" in AP 5.16, AP 5.17, the College Catalog, webpages and update the letter students receive when put on Academic Notice.

6. Unfinished Business

- a. Continue the Constitution and Bylaws Membership Discussion President Miralgia led a brief discussion about how to direct next year's Executive Council on Constitutional updates. The Council agreed that the goals next year should be:
 - 1. Deliberately reflect on the advantages and disadvantages of a smaller Executive Council in AY 2024-25.
 - 2. Use the Academic Senate plenaries to share and get feedback from the broader Senate membership about options for Constitutional change.

President Miralgia will bring back a resolution and more details to the next meeting for discussion and possible endorsement.

b. Purpose of EFF and Revised Guidelines

President Miralgia reviewed and accepted a number of endorsed changes with the Council, including a new name: Faculty Community Forum. The email forum will undergo a rebranding effort with the revised guidelines.

c. ASEC Committee Structures

1st Vice President Fanny Law led a discussion about the current committee structure. The Council provided some suggestions and President Miralgia suggested this item also be presented at the next Academic Senate Plenary.

 President Miralgia and Student Trustee Heather Brandt briefly discussed
 student needs and expectations related to syllabi, including the publication
 of syllabus before a semester starts and the role of student services
 information in the syllabus.

7. New Business

a. Draft Resolution renaming of School Dean Edie Kaeuper presented the process of selecting a new name for the School of Health & Physical Education & Social Services, and asked for endorsement of a new name. **Resolution 2024.04.03.7A** Resolution renaming School of Health & Physical Education & Social Services to School of Health and Public Safety

Whereas, two departments within the School of Health & Physical Education & Social Services have recently undergone name changes;

Whereas, the current title of the school inadvertently reflects the outdated name of one of its departments;

Whereas, a comprehensive, semester-long process involving the collaborative efforts of the dean and department chairs was undertaken to carefully evaluate and determine a name that would best represent the school, incorporating the recent departmental name changes;

Whereas, the selected name, "School of Health and Public Safety," received unanimous approval from all departments within the school;

Therefore, be it Resolved, that the Academic Senate for City College of San Francisco wholeheartedly endorses and supports the change of name from the School of Health & Physical Education & Social Services to the School of Health and Public Safety.

<u>Gen Ed and Grad Requirement Outcomes Revision for Title 5 and Cal-GETC Alignment</u>

Craig Kleinman, Curriculum Chair, introduced a Curriculum Committee resolution endorsing revised General Education and Graduation Requirements for Title 5 and Cal-GETC Alignment.

Resolution 2024.04.03.7A Gen Ed and Grad Requirement Outcomes Revision for Title 5 and Cal-GETC Alignment

Whereas, on November 29, 2023, the Academic Senate Executive Council's Resolution 2023.11.29.7F approved the Curriculum Committee's Resolution, CCSF General Education Pattern Changes to Comply with New Title 5 Regulations; i

Whereas, that resolution calls for "forming a GE Subcommittee to facilitate the implementation of the new local GE pattern by 1) making recommendations, as guidance from the State Chancellor's Office becomes

available, to the full Curriculum Committee to determine suitable processes determining suitable courses for new and adjusted GE areas; and 2) collaborating with the SLO team and SLO Committee to make necessary additions and adjustments to GE definitions, mapping, and GELOs"; ii

Whereas, the GE Subcommittee has met every other week during the spring '24 term; has included representation from Arts, Community and Public Health, Math, World Languages, English, ESL, Social and Behavioral Sciences, Library, and Communication Studies; has included additional discussion with the chairs of Math, Art, Photography, and Cinema, as well as regular Curriculum Committee discussion; has employed four different working documents to assess, share, and revise outcomes; has shared the outcomes writing with the Department Chair Council and encouraged their feedback; has made the outcomes revision progress accessible to all on Curriculum Committee agendas and minutes; has retained the majority of the current outcomes with minor editing and reserved deeper editing for brand new Title 5 areas (1B and 2), much of which was based on outcomes already used for CSU/IGETC Mapping; iii

Whereas, new GE outcomes need to be implemented in CurrIQunet by mid-April in order to complete the approval process necessary to meet various local and state deadlines; therefore, be it

Resolved, GE outcomes mapping will be completed prior to the first fall '24 Curriculum Committee meeting; GE assessment will continue to be overseen by the SLO Team according to their established practice, with outcomes revised as needed.
