Part of Student Centered Funding Formula (SCFF)

- We are currently funded under the hold harmless freeze.
- Our state revenue is frozen at \$166,711,708
- No "Cliff" or reduction of funding will occur

• Therefore calculation of the SCFF is done **only** to determine when we can break through the ceiling of \$166,711,708 and thereby receive additional funding.

Center Funding is only one part of the SCFF- We will focus on that

• 2024/25 Center funding is as follows determine by FTES at each center.

• Downtown Center is in a separate Category and must have >1000 to get anything.

- The Education Code instituted a freeze on Center Census during the pandemic which will expire in 2026/2027
- Our FTES at centers has fallen during the pandemic and after, which will affect us in 2026/27
- Dr. Ligioso together with Monica Liu have determined FTES numbers at the Centers with a projection for 2026/2027.
