

Guidance for City College of San Francisco Students in the Event of Immigration Enforcement Actions at Ocean Campus and/or at Centers

(Current as of 01/29/2025)

City College of San Francisco is dedicated to supporting all students, regardless of immigration status, as they pursue their educational goals.

We understand that many in our community may be feeling uncertain or anxious, and we are committed to doing everything we can to support students' continued well-being and safety.

One concrete action all students can take now is to prepare for the possibility of immigration enforcement actions that may occur at City College's campus and centers.

We have identified resources for those who want to learn more about the rights and responsibilities of individuals interacting with immigration offices. We have also identified a point-of-contact for students if they are contacted by immigration officers while at City College, along with additional resources that may be helpful.

PROTECTIONS

Please be aware what City College means when using the term sanctuary college/campus. This term is philosophical and aspirational. It is not a legally defined or established term and no additional authorities are granted to or are available for the College. CCSF's intention with this designation is to provide a safe, welcoming, supportive educational environment for undocumented students and to assemble and leverage resources that inform and support those students. The term is borrowed from the City of San Francisco's declaration as a sanctuary city.

However, there are legal and policy protections provided by the State of California and City College:

- CCSF will continue to prohibit District Police from participation in immigration-related activities and the sharing of student and employee information unless compelled to do so by court order. District Police will not contact, detain, question, or arrest any individual based solely on suspected undocumented immigration status or inquire about an individual's immigration status.
- Assembly Bill (AB) 21 and Senate Bill (SB) 54 prohibit state and local agencies from using resources to further certain federal immigration enforcement efforts.

WHAT TO DO

- 1. If you are approached by an immigration officer while at City College, remain calm and do not panic.
- 2. Assert your rights as stated on the red card. ALL individuals have rights under the United States Constitution. Exercising your constitutional rights IS your right.
 - **Get Your** Red Cards: City Dream and the Immigrant Legal Resource Center offer free Red Cards, which provide quick, user-friendly reminders for asserting your rights and protecting yourself in various situations, including interactions with immigration officers. Once you click on the link, scroll down to find your preferred language.



3. Immediately contact CCSF District Police (415-239-3200) if you are approached by an immigration officer on Ocean campus or at a Center. District Police are committed to protecting the safety and well-being of all members of our community, including undocumented students. They will help to address the situation with the federal officers while respecting and protecting your rights.
